This Offer of Judgment is made for the purposes specified in Rule 68 of the Federal Rules of Civil Procedure and is not to be construed as an admission of liability or wrongdoing by any of Defendants, or any owner, employee, representative, or agent of any of Defendants; nor is it an admission that any of Plaintiffs has suffered any loss or damage.

Acceptance of this Offer of Judgment will act to release and discharge Defendants, their respective successors or assigns, as well as all past and present owners, employees, representatives, and agents of Defendants, from any and all claims that were or could have been alleged by any of Plaintiffs in the above-referenced action under the FLSA. Acceptance of this Offer of Judgment also will operate to waive any right any Plaintiff may have to any claim for interest on the amount of the judgment or for any further attorneys' fees or costs incurred in connection with the above-referenced action.

In order for Plaintiffs to accept this Offer of Judgement, Plaintiffs must serve written notice of acceptance upon Defendants within fourteen (14) days after service of this Offer of Judgment.

An offer not accepted within the specified period for acceptance will be deemed withdrawn.
